Introduction

Free Trial

- **Duration:** The Service includes a 30-day free trial period.

Payment and Subscription

- **Billing:** After the free trial period, you will be required to provide payment information and select a subscription plan.
- **Invoices:** Payments are made by invoice. You agree to pay all invoices issued by Buildcloud Construction AB within the specified due date.
- **Late Payment:** Late payments may result in suspension or termination of your access to the Service.

User Accounts

- **Registration:** You must register for an account to use the Service. You agree to provide accurate and complete information during registration.
